**SUBJECT: August Status Report** 

The following status report is submitted for your review and consideration.

## 1. Public and Environmental Health

## **Operators of the Year**

Operations staff have nominated a 2023 candidate from each plant for "Operator of the Year." Nominated individuals are recognized for facility contributions, operational knowledge, public relation efforts, educating/training others in wastewater, attendance, and exemplary performance. Larry Andresen was selected as Operator of the Year for Plant No. 1 and Tim Tran was selected as Operator of the Year for Plant No. 2. From these candidates, Larry Andresen was selected and will be nominated as the Operator of the Year at the regional and state level for the California Water Environment Association.

# 2. Sound Finances and Increasing Efficiency

# **Headquarters Skybridge Milestone**

A 100-foot bridge section spanning across Ellis Avenue was successfully installed on July 22. In addition to the video shared at last month's Board Meeting, HDR prepared a video with drone footage and photos and shared it with staff. Both videos can be found on the project website at <a href="www.ocsan.gov/headquarters">www.ocsan.gov/headquarters</a>. The 80-foot steel section of the bridge connected to the headquarters building was also installed the same day. On the plant side, the elevator tower which will connect the last section of the bridge is currently in construction. Inside the building, interior activity continues including drywall, paint, and tile. The project is scheduled for completion in the first quarter of 2024.

# **Adding Redundancy for Internet Services**

OC San has been using a single Internet Service Provider (ISP), currently Frontier Communications. OC San is at risk of network outages due to physical wiring damage or Frontier's internal network routing problems. The workplace today is

more reliant upon the internet for supporting business operations because of telecommuting and cloud applications. Adding a new internet circuit from a different ISP will increase the stability and provide redundancy. Verizon will be the ISP for Plant No. 1 and Frontier will remain as the ISP for Plant No. 2. In the event of one having an outage, internet traffic will be rerouted to the other ISP. We estimate implementation to be mid-September as we are currently waiting for professional services to configure the FortiGate firewall.

## 3. Recovering Valuable Resources

## Supercritical Water Oxidation (SCWO) Demonstration Project Update

The AirSCWO 6 system is expected to arrive in the upcoming months from Indiana. Once the system is installed, there will be the pilot start-up and commissioning followed by the six ton per day demonstration performance testing. This project will test the treatment of raw sludge, biosolids, and food waste.

# Groundwater Replenishment System (GWRS) Year-End Summary

With the completion of the final phase of the GWRS, OC San made available additional amounts of highly treated wastewater to the Orange County Water District (OCWD) to produce high-quality water to replenish Orange County's groundwater basin and protect the basin from seawater intrusion. For fiscal year 2022-2023, a daily average of 186 million gallons of wastewater was received, OC San made available an average of 154 million gallons a day of highly treated wastewater for GWRS.

## **Dry Weather Urban Runoff Year End Summary**

In fiscal year 2022-2023, OC San received an estimated daily average of 1.55 million gallons of dry weather urban runoff. Of the 21 diversions at the beginning of the fiscal year, one low-flow diversion was terminated by the City of Newport Beach (Big Canyon) in January 2023, and a high-flow diversion (Santa Ana/Delhi) was completed by Orange County Flood Control District and began discharging in April 2023. Two other diversions have been constructed by the City of Newport Beach (Arches-Hoag and Arches-Old Newport) and are expected to begin operation in fiscal year 2023-2024.

# 4. Community Outreach and Transparency

## **Engaging with the Community**

This month, OC San participated in four tours. Some of the guests included Yorba Linda Councilmember Janice Lim, and City Manager Mark Pulone, staff from Costa Mesa Sanitary District, and the Municipal Water District of Orange County. I also

presented at the Water Advisory Committee of Orange County on the Supercritical Water Oxidation Project.

## 5. Legislative and Industry Affairs

## State Update

The first half of July featured numerous legislative policy committees as the Legislature worked to consider bills before the July 14 second house policy committee deadline. Upon adjournment on July 14, the Legislature started their summer recess and returned on August 14. Despite the lack of legislative activity at the end of the month, July is a critical time for behind-the-scenes negotiations on bills and funding activity as the Legislature gears up to tackle the final month of the legislative session. As of their return on August 14, the Legislature will have 1,231 measures to consider before adjourning for the Interim Recess on September 14.

## Federal Update

The recent Congressional action centered on fiscal year 2024 appropriations and development of PFAS legislation by the Senate Committee on Environment and Public Works. Of note, was the understanding that the enactment of spending bills before the beginning of the new fiscal year, October 1, is impossible. From this, what is top of mind is "will they or won't they" shut down the government when spending authority lapses on September 30. It is possible that a stop gap spending bill could be approved to avoid a shut down on October 1. The difference within the House and Senate membership over spending levels could lead to arduous floor debates that force a shutdown for a short time. Action on PFAS legislation continues with potential Senate hearings in late September at the earliest.

# OC San's Legislative and Regulatory Planning Begins

This month kicked off the planning and preparation for OC San's Legislative and Regulatory Plan. During the months of August and September, staff and our legislative consultants will review our current plan, meet with our external partners, and our internal resident experts to draft the plan that will then come before the Steering Committee. This plan is used as the guiding document for all legislative and regulatory activities that will be taken for calendar year 2024.

## OC San Receives Accolades

 The California Association of Sanitation Agencies (CASA) awarded OC San and the Orange County Water District with the 2023 Capital Project Award for the Final Completion of the Groundwater Replenishment System. I accepted the award at the CASA Conference on August 10.

- OC San received the ESRI Special Achievement Award in GIS. Our Ocean Monitoring program uses ArcGIS to ensure safe water for swimming, healthy marine populations, seafood is safe to consume and good water quality. OC San was one of 197 chosen from more than 100,000 ESRI clients worldwide. ESRI users are nominated by ESRI leadership and distributor organizations, with finalists selected by the President and founder of ESRI.
- OC San won two awards from the American Inhouse Design Awards from Graphic Design USA. It is a premier competition for design professionals, with over 7,000 entries and only 10 percent recognized as a winner. The awards were given for the banners on the light poles and for the 2021-2022 Capital Improvement Program Annual Report.
- OC San and the Orange County Water District's Groundwater Replenishment System Project has been awarded the Project Excellence Award from the Water Environment Federation. The award will be presented at the October Water Environment Federation Technical Conference.

# 6. Workforce and Administration

## Strategic Planning Process Update

The Strategic Planning process is wrapping up which leads to the next phase. Over the next month, staff will be making necessary updates and compiling the plan based on feedback received from the Board. A draft of the 2023 Strategic Plan will be presented in September, with approval scheduled for November.

## Staff Appreciation Luncheon

On Wednesday, August 16, OC San and the Orange County Water District hosted an appreciation lunch for staff from both agencies highlighting the completion of the Groundwater Replenishment System.

## OC San Participates in Industry Conferences

This month, I had the opportunity to attend the California Association of Sanitation Agencies (CASA) annual conference to hear about "The New Water Era" which was this year's theme. I attended various meetings and presentations of topics that will be shared with management. Later this month, I will also be attending the California Special Districts Association (CSDA) annual conference to continue meeting and collaborating on water issues affecting our industry.
