SUBJECT: Order to Cease Discharge

RE: Permit No. 1-600975

This letter serves to notify Golden State Pumping LLC (Golden State) that the Orange County Sanitation District (OCSD) Class 1 Wastewater Discharge Permit No 1-600975 issued for the facility located at 1051 N Patt St. in Anaheim has been **voided on November 30, 2020** due to no discharge from process operations.

Through recent site inspections and correspondence with facility representatives, it is OCSD's understanding that grease rendering operations at Golden State have ceased as a result of local municipal code violations. It was also determined that Golden State has elected to vacate the premises and relocate to an alternate location.

Wastewater discharge from facility shutdown processes are not authorized under Permit No. 1-600975, and Golden State has not notified OCSD of a need to discharge to facilitate the facility cleanup and shutdown, nor has the facility provided OCSD a plan of closure to this effect.

Therefore, pursuant to provision of OCSD's Ordinance and OCSD Class 1 Wastewater Discharge Permit No. 1-600975, Golden State is hereby Ordered to Cease Discharge to OCSD's sewerage facilities immediately.

If Golden State needs to discharge as a result of the facility cleanup and shutdown, a request and closure plan must be submitted to OCSD, and a written authorization must be received from OCSD, prior to Golden State commencing discharge.

Please be advised that OCSD may conduct an inspection of Golden State to confirm the termination of discharge to the sewer system.

Golden State is reminded that pursuant to the authority of California Government Code Sections 54739-54740 and OCSD's Wastewater Discharge Regulations (Ordinance OCSD-53) Section 616, any person who violates any provision of the OCSD's Ordinance will be liable up to \$25,000.00 per violation for each day that such a violation occurs. In addition, pursuant to Sections 54740.5 and 54740.6, administrative fines may be assessed up to \$5,000.00 per violation or up to \$10.00 per gallon for discharging without a permit.
