

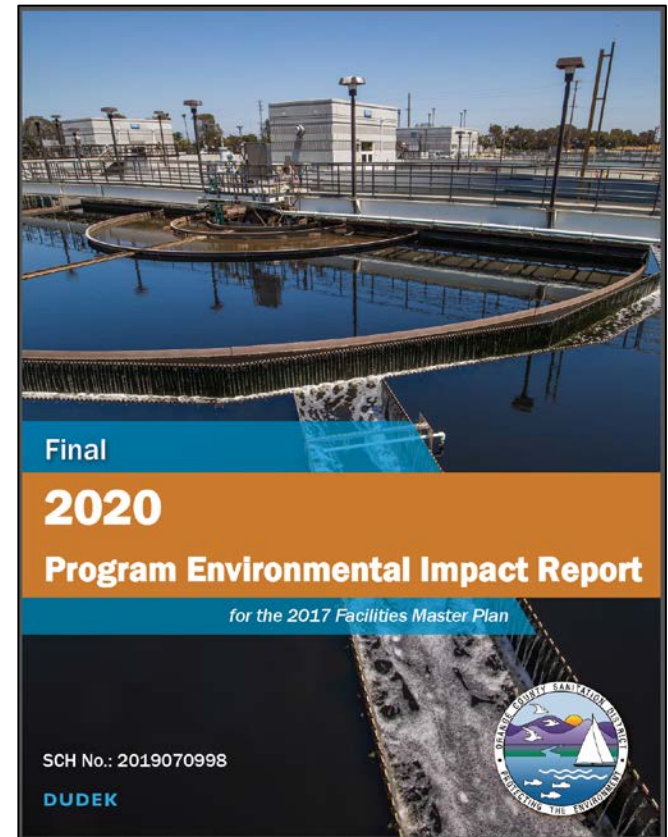
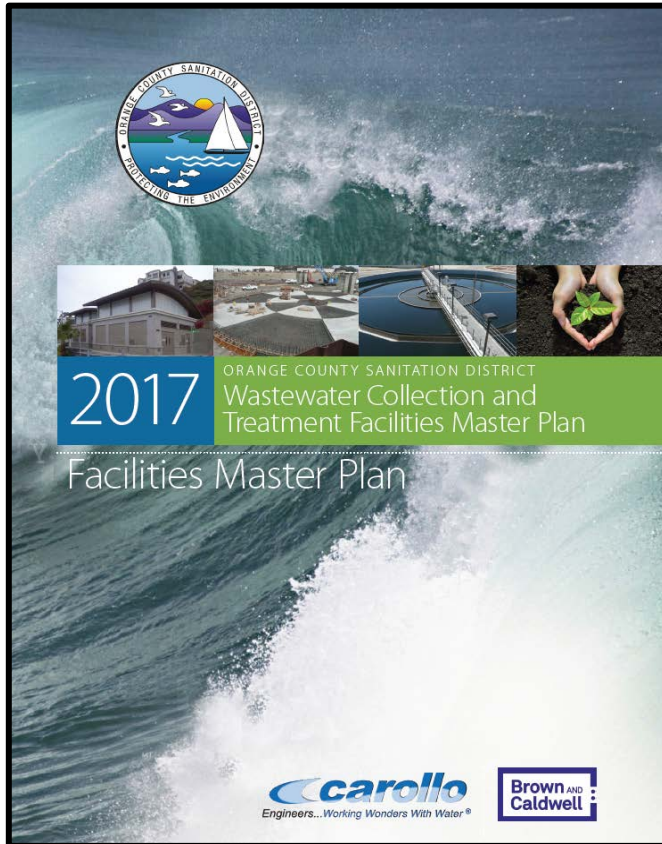

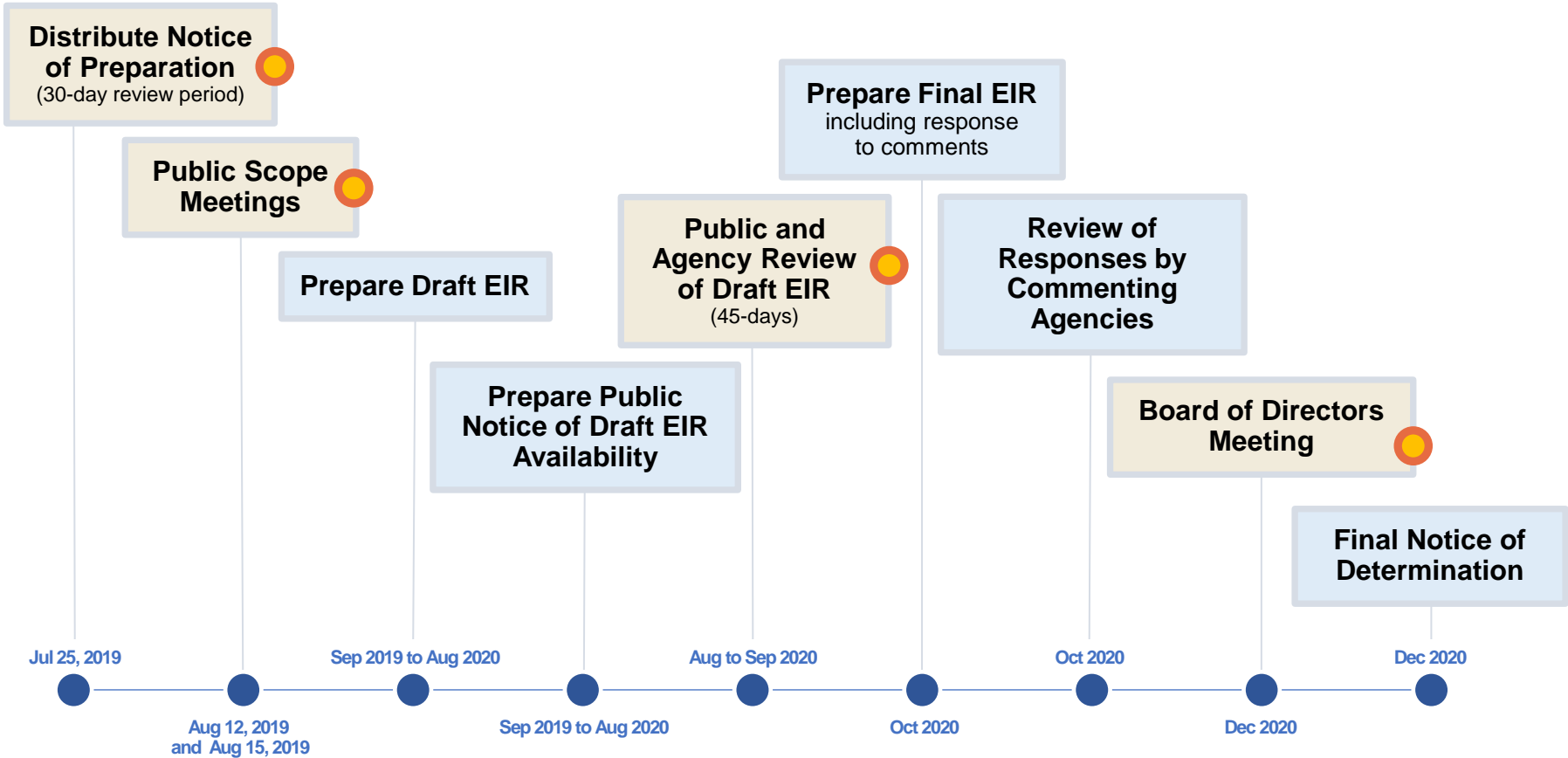



2017 Facilities Master Plan



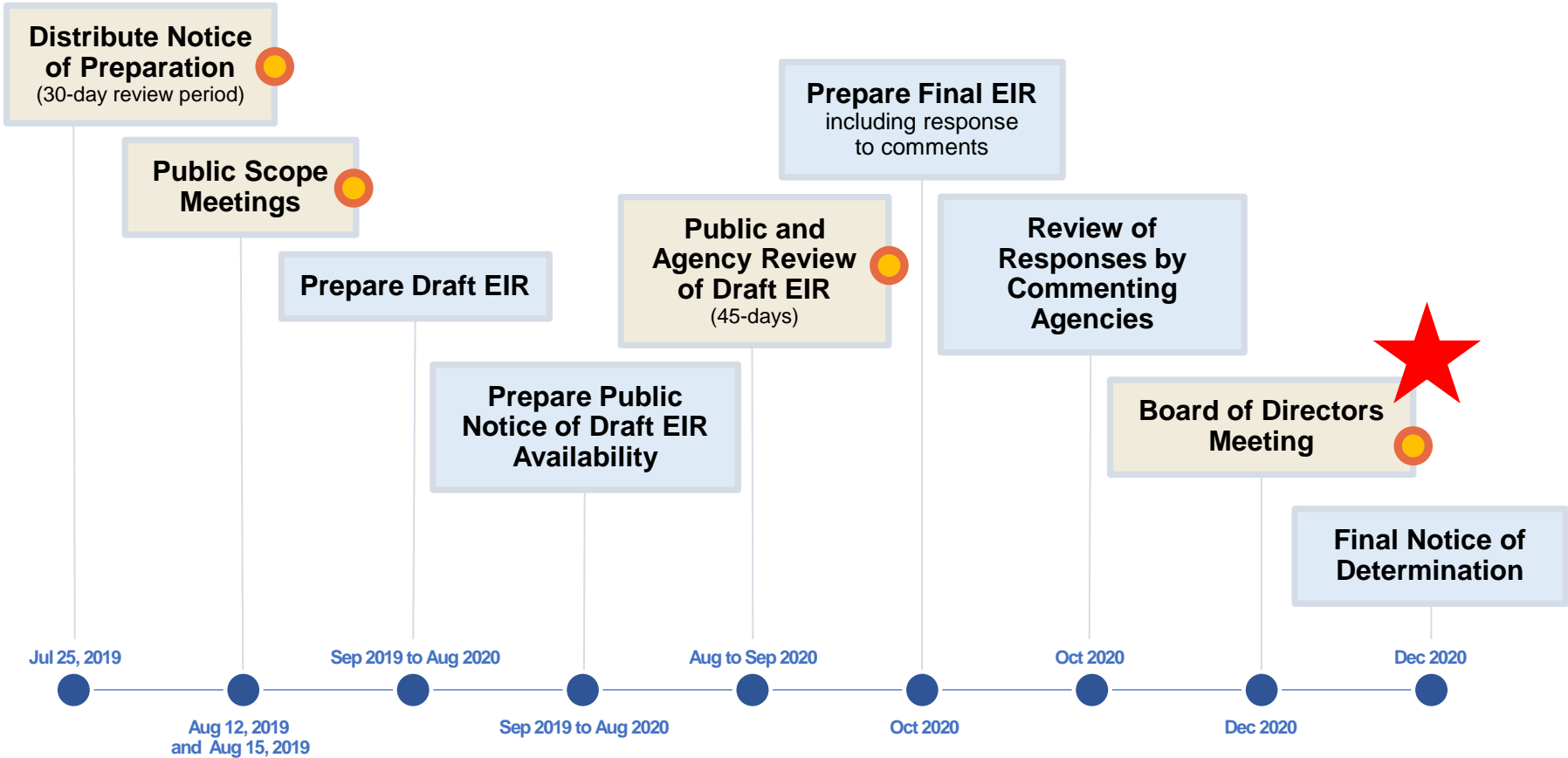
- Basis for this Program Environmental Impact Report (EIR)

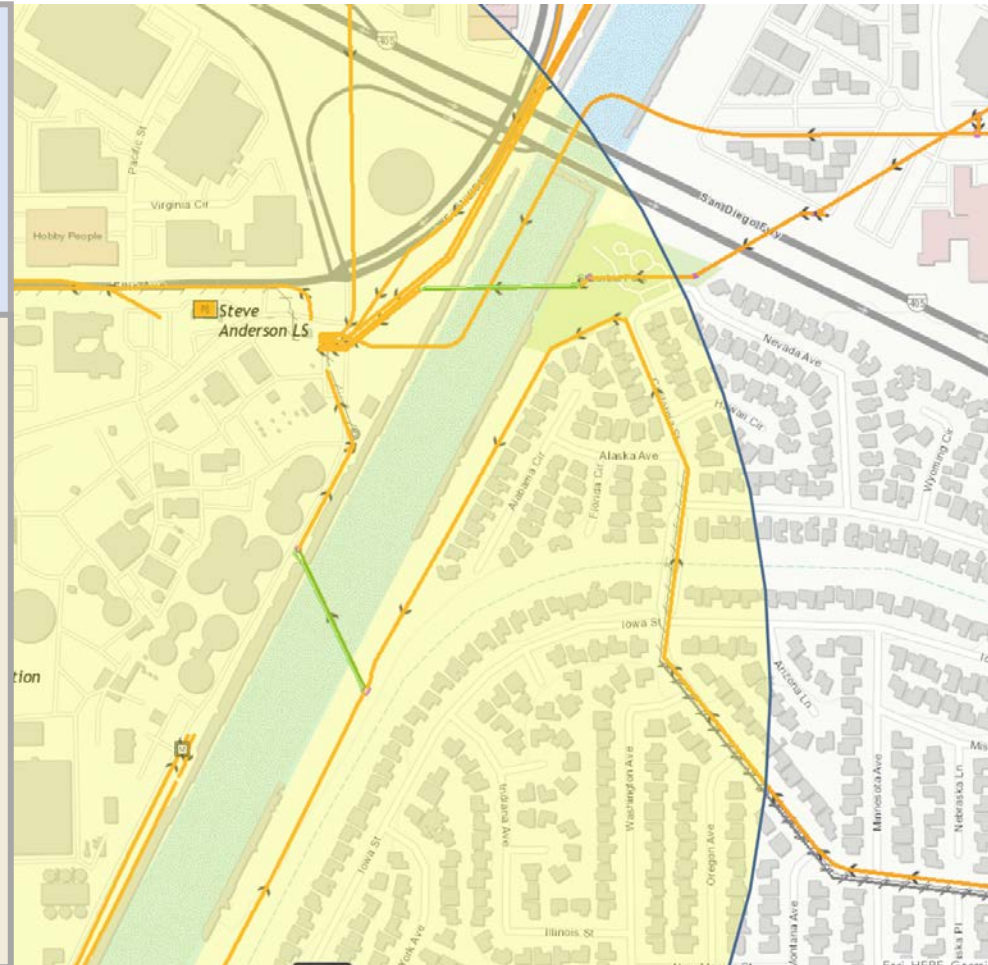

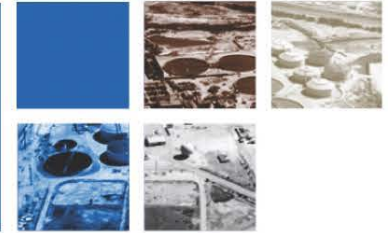
Mailouts and Notifications:

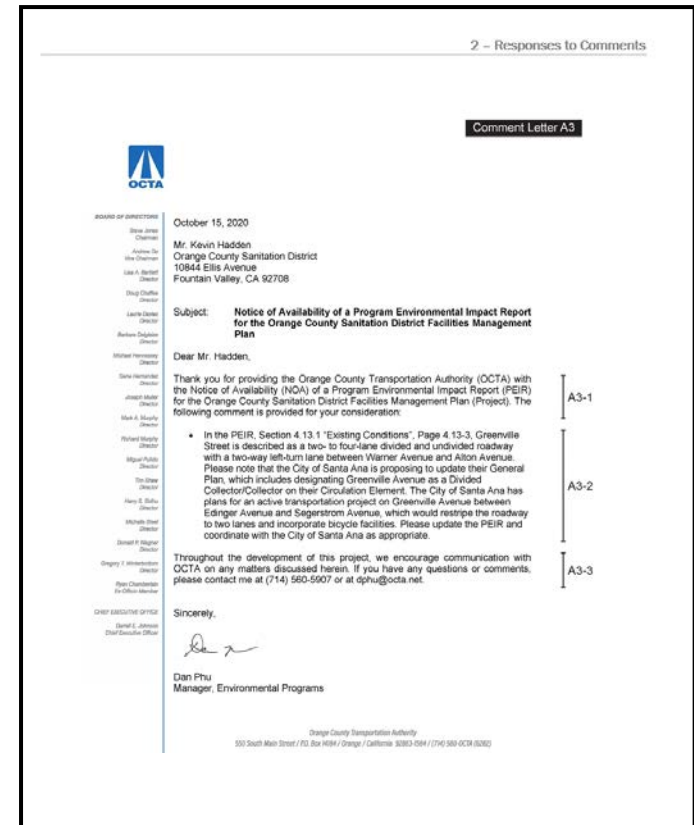
