SUBJECT: January Status Report

The following status report is submitted for your review and consideration.

1. Public and Environmental Health

OC San Selected to Receive Federal Funding

OC San has been notified that we have been selected to receive funding for the Supercritical Water Oxidation (SCWO) project in the amount of \$3.45 million through the Federally run Community Partnering Program. The SCWO will support a six-tonper-day demonstration project called AirSCWO Nix6. Our staff and consultants are reviewing the criteria and requirements to ensure that we can comply with the EPA's funding requirements.

2. Sound Finances and Increasing Efficiency

Construction of the New Headquarters Building Continues

Mass timber installation is completed, and interior and exterior framing is ongoing. The furnishings, fixtures, and equipment package was finalized in December, and we anticipate getting pricing from vendors by the end of the month. Staff will then review each vendor and pricing and provide a recommendation to the Board of Directors at a future Operations Committee meeting. An information update on the educational exhibit will be provided at this month's Steering Committee meeting.

OC San Kicks Off Budget Update

This month, we initiated the development process for updating the 2023/24 budget which is scheduled for adoption in June. As part of this process, there will be a series of budget presentations to both the Administration and Operation Committees. The presentations will focus on OC San revenues, expenditure categories, line items, operational activities, and the Capital Improvement Program.

Capital Improvement Program Validation Underway

OC San actively manages a \$6.1 billion, 20-year Capital Improvement Program (CIP) comprised of over 70 active and future capital projects. On an annual basis, staff conducts a review process of the current and upcoming CIP projects to validate the proposed scope, schedule, resources needed, timing, risks, and cost to confirm budgetary requirements. The overall CIP budget will be presented as part of the overall budget review.

Sewer Service Fee Notifications will be Mailed in February

OC San's current five-year sewer fee rate schedule expires at the end of the current fiscal year. Staff, working with an independent engineering consulting firm, conducted an analysis of OC San's cash flow modeling and a comprehensive cost of service study to develop a new schedule that will support OC San's programs while maintaining appropriate reserve levels. During the December Board meeting, staff was directed to prepare and mail Proposition 218 compliant notifications to affected property owners outlining a five-year regional sewer service fee schedule with annual increases of approximately 3.5 percent for fiscal years 2023-24 through 2027-28. These notices will be mailed to over 500,000 properties throughout Orange County during the first week of February. This notice will also be posted on www.ocsan.gov in English, Spanish and Vietnamese languages.

3. Recovering Valuable Resources

GWRS Receives Flow from Plant No. 2

Last month the Orange County Water District (OCWD) began processing reclaimable flows from Plant No. 2 at the expanded Groundwater Replenishment System (GWRS) in Fountain Valley. With the treatment plant process now able to separate "reclaimable" and "non-reclaimable" flows, OC San is meeting the Strategic Plan goal of recycling 100 percent of reclaimable flow. The GWRS final expansion facilities are currently undergoing performance testing, and OC San and OCWD continue working together closely to ensure successful GWRS operation during this time.

4. Community Outreach and Transparency

Virtual Tours and Presentations

This month, staff held a virtual tour for the City of Huntington Beach and East Valley Water District. In addition, Assistant General Manager, Rob Thompson and I presented at the Association of California Cities – Orange County Newly Elected Officials Orientation.

5. Legislative and Industry Affairs

State Update

This month began the start of the 2023-24 Legislative Session where the Governor unveiled his proposed state budget spending plan. The January proposed budget will

initiate the process between the Administration and the Legislature on how best to appropriate tax revenues. Additionally, February 17 is the bill introduction deadline.

Federal Update

Congress convened for the 118th Congress. The focus will be on oversight of the Biden Administration's infrastructure and climate resilience policies, adopting a federal budget for FY 2024, increasing the debt ceiling, and debating whether to pull back some of the funding provided in the Inflation Reduction Act by relying on a new budget reconciliation package.

6. Workforce and Administration

Board Orientation Scheduled for February

With the addition of several newly appointed Board Members and Alternate Board Members, OC San will host a virtual Board Orientation on February 15 to provide a glimpse into OC San, our operations, practices, and status. In person tours will also be available in March. Specific details will be provided to you by the Clerk of the Board.

General Manager Work Plan Mid-Year Update

January marks the mid-year update for my 2022-2023 General Manager's Work Plan. As you will see in the agenda packet, thus far six of the 17 goals identified in the plan have been completed. A full update on each goal is included in the memo.

OC San's New General Manager

This monthly report is my last as your General Manager. As you all know, on February 10th, Rob Thompson will take over as the next OC San General Manager. Communication on the transition is underway to ensure our member agencies and industry partners are aware of Rob's new role. A press release announcing the new leadership was distributed on January 3.

Quarterly Performance Dashboard

OC San measures performance metrics tied to the Strategic Plan Levels of Service. These service levels are the commitments made to our customers, regulators, employees, and the Board of Directors that reflect how well OC San is meeting its mission. Each quarter, I will include the attached report with a selection of the performance metrics included in the Strategic Plan, providing a high-level overview of OC San's performance.

OC San U Mid-Year Update

Fiscal year 2022-23 marks the third year of OC San "U", OC San's renewed and currently all-virtual, voluntary employee development program. Learning options continue to include monthly webinars, online courses, a mentoring program, and the CSUF leadership academy. This fiscal year, in addition to OC San employees, seats are being extended from two courses to employees of our member agencies. The first course was offered in November and was well-received. Approximately thirty Board


employees attended from seven agencies. The next course is planned for April and will be announced soon.







OC San Quarterly Dashboard of Operational Performance Metrics







